## WHAT IS THE ENERGY-OPS SECURITY AGORA INITIATIVE?

The Energy-Ops Security Agora initiative aims to bring together security heads and other key actors across Oil and Energy supply chains to address collectively the security issues and operational challenges that burden the Energy industry through costs, disruption, and political and social instability.

In addition to serving as a problem-solving forum for our Energy industry representatives, the Energy-Ops Security Agora initiative will also incorporate carefully selected vendor offerings for consideration as potential tools in those solutions.

## HOW THE AGORA AGENDA AND PROGRAMME IS BUILT?



Each participant consults on an initial call with Agora representatives to discuss his or her role and responsibilities in supply chain security



Starting with those conversations, we develop discussions identifying critical issues, their root causes and modalities, and possible measures to resolve or mitigate them



On the basis of those discussions, we map key challenges and potential solutions, and then construct the Agora agenda around both regional and global issues

### **What is the Agora format?**

- Chatham House Rule: unrecorded, unreferenced, pre-qualified participants, no media allowed
- Five or six 45-minute interactive sessions per day
- To maximize collaborative problem-solving, in each session a 15-minute use case will be followed by 30 minutes of discussion and debate
- Key takeaways from the sessions will be collated and distributed for use as reference points and benchmarks going forward
- When in-person gatherings are feasible, the agenda will include welcome and mid-morning coffee breaks, a networking lunch, and post-event drinks in the early evening



## How does the Virtual Agora work?

- Amid the global pandemic, we have adopted an abbreviated Virtual Agora.
