CHATHAM HOUSE RULE

All Agora Nexus activities operate under the Chatham House Rule of engagement

Purpose:

The rule aims to foster open and frank discussions by allowing individuals to express opinions and share information without fear of professional repercussions or embarrassment.

How it works:

Participants are free to use the information they receive during a meeting held under the Chatham House Rule, but they must not attribute any statements or actions to specific individuals or organizations

HOW CY-SEC AGORA MAURITIUS ONBOARDS ITS MEMBERS AND CONSTRUCTS CONTENT?



Each executive consults on an initial call with Agora representatives to discuss his or her role and responsibilities within the Mauritian IT & Cyber Security ecosystem

(NB: all execs must be active end users with Mauritian remit)



Starting with those conversations, we develop personal relationships with all members, identifying pain points, critical issues, their root causes and modalities, and possible measures to resolve or mitigate them



On the basis of those discussions and ongoing engagements, we map key challenges and potential solutions, and then construct the Agora agenda's around both regional and global issues

What is an Agora Clinic?

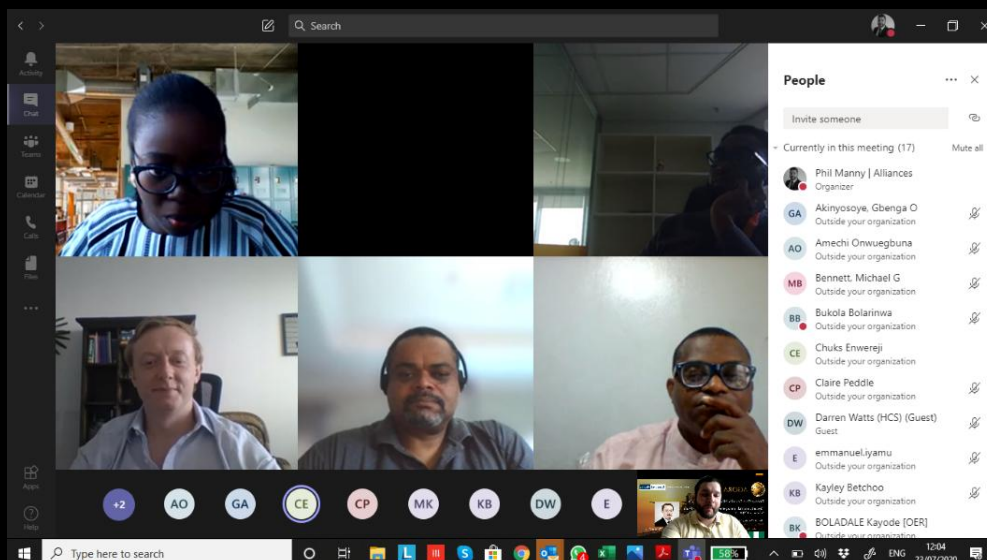
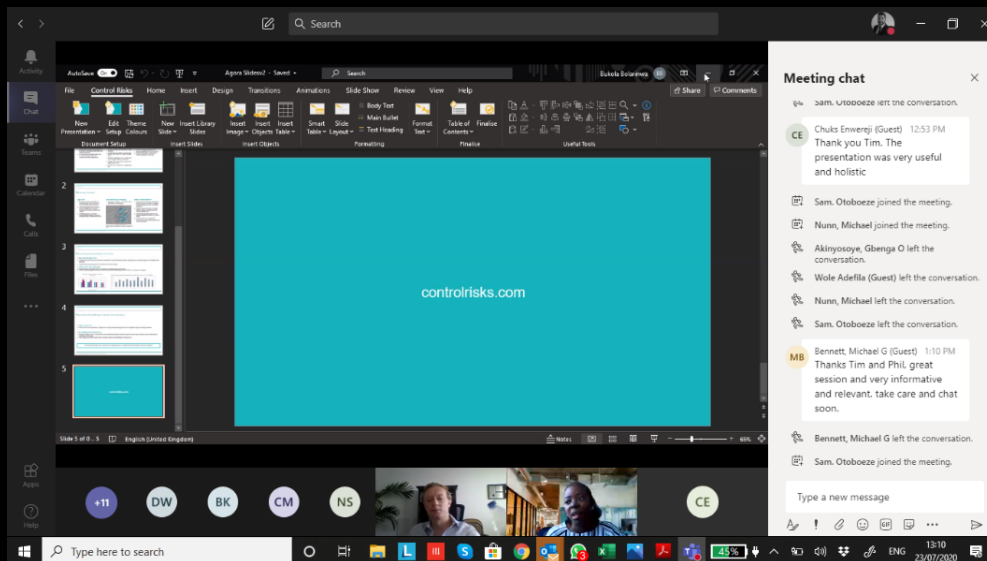
- Similar to a clinic for medical purposes (where people go for medical care or advice), the Agora Clinic will act as group therapy environment for all security related queries.
- This will take place as a drop-in call session which will either be in the form of open forum or based on pre-requested topic.
- Objective to prescribe possible solutions and takeaways
- The Agora Clinic will as with all activities maintain the Chatham House Rule for confidentiality.



VA VIRTUAL AGORA

How does the Virtual Agora work?

- Amid the global pandemic and the shift to WFH, we introduced an abbreviated Virtual Agora.
- In-person Agoras will be supported by more frequent gatherings in the virtual world.
- The Virtual Agora maintains Chatham House Rule.
- Each Virtual Agora session follows the programme of either a standalone fireside chat or panel discussion, followed by interaction and debate.
